LEGAL AND OTHERS REQUIREMENT COMPLIANCE

ISO 45001:2018 requires demonstration of compliance with the above legal requirements. It requires a committed policy of legal compliance together with monitoring and updating processes to maintain regulatory compliance.

It is the SLG Construction Sdn Bhd responsibility to evaluate its own compliance and OS&H auditors are to ensure the legal requirements have been addressed periodically.

The main legislation and regulations covering OS&H which is applicable to SLG Construction Sdn Bhd are the following:

- **Occupational Safety and Health Act 1994 (Act 514)**

The application: Provision for securing the safety, health and welfare of persons at work, for protecting others against risks to safety or health in connection with the activities of persons at work, to establish the National Council for Occupational Safety and Health and for matters connected therewith.

- **Fire Services Act, 1988**

The application: Provision for effective and efficient functioning of the Fire Services Department, for the protection of persons and property from fire risks and for purposes connected therewith.

- **Uniform Building by Law**

The application: Provision for securing for the building safety as per requirements.

- **Other requirements related to Safety & Health**

Depending on its circumstances and needs, SLG Construction Sdn Bhd may subscribe voluntarily to requirements, other than legal requirements, that apply to the health and safety aspects of its activities:

- Agreements with public authorities such as local DOSH office and BOMBA
- Agreements with customers
- Non-regulatory guidelines (non-mandatory)
- Guidelines on first aid facilities
